# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to SAN-A-CAN.COM and San-A-Can Inc and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to San-A-Can Inc include SAN-A-CAN.COM and San-A-Can. The San-A-Can website is a ecommerce site. By using the San-A-Can website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, San-A-Can may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase San-A-Can's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. #### **Use of your Personal Information**

San-A-Can collects and uses your personal information to operate its website(s) and deliver the services you have requested.

San-A-Can may also use your personally identifiable information to inform you of other products or services available from San-A-Can and its affiliates.

#### **Sharing Information with Third Parties**

San-A-Can does not sell, rent or lease its customer lists to third parties.

San-A-Can may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to San-A-Can, and they are required to maintain the confidentiality of your information.

## **Tracking User Behavior**

# **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by San-A-Can. #### **Use of Cookies**

The San-A-Can website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.
